## ESTIMATE OF STANDARD COSTS FOR UNITED STATES RESIDENTS WITH AN OREGON OR COLORADO SURROGATE

The information below is meant to assist you in planning your surrogacy and is only an estimate. There are many factors that determine the overall cost of a surrogacy. Yours may cost more or less depending on your circumstances. These amounts are subject to change without notice, and do not include IVF, outside IVF monitoring, embryo testing, or egg donor expenses.

<b>NORTHWEST SURROGACY CENTER, LLC AGENCY FEE.</b> Our fee includes the following services: locating and screening suitable surrogate candidates, facilitating meetings between you and potential surrogates, coordinating with other surrogacy professionals, and providing support for both parties throughout the process.	
First installment (due upon execution of our fee agreement)	\$10,000
Second installment (due upon execution of your surrogacy contract)	\$10,000
Final installment (due upon confirmation of pregnancy by ultrasound)	\$2,000

<b>SURROGATE NON-MEDICAL SCREENING, PRE-MATCH TRAVEL, AND HEALTH INSURANCE EXPENSES.</b> At the time you sign up with our agency, you will pay a one-time flat fee for your future surrogate's non-medical screening expenses. This fee covers the cost of her criminal background check, psychological evaluation, home visit, and pre-match travel expenses. It also covers the pre-match monthly premiums for her health insurance.

<b>SURROGATE EXPENSES AND COMPENSATION.</b> After you have been matched with a surrogate you will be asked to establish a trust account for her. You will make an initial deposit of \$4,000 to cover her expenses until the surrogacy contract is signed. At that time you will deposit the rest of the estimated amount, based on the specifics of your contract, to pay for her compensation and expenses.

**SURROGATE PREGNANCY AND DELIVERY MEDICAL EXPENSES.** You will pay for your surrogate’s uncovered pregnancy and delivery medical expenses, including deductibles, co-pays and prescriptions. This amount depends on medical circumstances and insurance, and does not include IVF medical expenses or newborn medical expenses incurred.

## ESTIMATE OF VARIABLE COSTS FOR UNITED STATES RESIDENTS WITH AN OREGON OR COLORADO SURROGATE

In addition to the standard costs, there are a number of other costs that may be incurred during the surrogacy process. These additional costs can vary widely and are different for each individual case. The figures provided are estimates only.

<b>COMPENSATION AND EXPENSES FOR SURROGATE BED REST.</b> If your surrogate has medical complications and is placed on bed rest or required to reduce hours of employment, you will compensate her for lost wages, childcare, and housekeeping.	
Lost wages for bed rest (varies based on income and extent of medical complications)	Varies
Childcare (\$12-\$16 per hour; varies based on amount required beyond usual)	Varies
Housekeeping (approximately \$80 per week)	Varies
<b>TRAVEL EXPENSES FOR SURROGATE.</b> If your surrogate is required to travel more than 50 miles one way for screening and/or medical appointments, you will reimburse her for mileage, lodging, and meals.	
Travel expenses (ranges between \$0 and \$4,800)	Varies

## OTHER EXPENSES ASSOCIATED WITH SURROGACY

NWSC may provide escrow services to pay these expenses however they are not expenses paid to NWSC or the surrogate.

**LEGAL FEES.** NWSC prepares the draft surrogacy contract, but each party will retain independent legal counsel to review and discuss the contract. You will pay your own attorney fees as well as attorney fees for the surrogate and her spouse or partner. The legal representation estimate also includes fees for legal proceedings in connection with the establishment of parental rights. Please note that legal fees vary and are paid directly to the attorney. Portland attorneys typically charge between \$250 and \$350 per hour.

**INSURANCE FOR SURROGATE.** If your surrogate does not have medical or life insurance or if her insurance is inadequate, you will provide medical insurance for prenatal care, delivery, and post-partum care, as well as a life insurance policy.
