# Fees and Expenses

## FOR INTENDED PARENTS

### NORTHWEST SURROGACY CENTER, LLC AGENCY FEES

Our fee includes locating and screening suitable surrogate candidates, facilitating meetings between you and potential surrogates, coordinating with other surrogacy professionals, and providing support for both parties throughout the process.

First Agency Fee (due upon signing NWSC fee agreement)	\$22,500
Second Agency Fee (due upon execution of your surrogate contract)	\$16,000

### NON-MEDICAL SCREENING FEE

When you sign with NWSC, you will pay a one-time flat fee for your future surrogate's non-medical screening expenses that covers her background checks, psychological evaluation, home visit, pre-match travel expenses, and pre-match health insurance.

### LEGAL AND ADMINISTRATIVE FEES

NWSC will prepare the draft surrogacy contract, but each party will retain independent legal counsel for the contract review and parentage proceedings. These costs can vary depending on the attorneys, the surrogate's state of residence, and your legal needs. Court costs are paid separately.

## SURROGATE MEDICAL BILLS AND INSURANCE

You are responsible for your surrogate's pregnancy and delivery medical expenses, including health insurance. The amounts listed below do not include additional costs associated with specialty surrogacy policies or health policies with a surrogacy lien provision.

## VARIABLE EXPENSES FOR SURROGATE

Reimbursement costs are based on the surrogate's actual expenses at the time of the event. Surrogate may be required to provide receipts, proof of income, and/or doctor's letter.

Invasive Procedure (fee is per procedure)	\$1,000
Termination of Pregnancy (after end of 13th week)	\$2,000
Loss of Uterus	\$5,000
Loss of Ovary, Ovaries, and/or Fallopian Tube(s)	\$2,500

Expenses marked with an asterisk (\*) will be paid by you directly to the providers - they are not paid from the escrow account.

This estimate does not include: health insurance or medical expenses for your newborn, or any IVF fertility clinic costs including embryo creation, testing, and storage, donor fees and expenses, and surrogate IVF cycle preparation, medication, and outside monitoring.
